• The resolution for the furniture bid for Rocky River High School, Kensington Intermediate School and Goldwood Primary School was approved at the Special Board of Education Meeting held prior to the Committee-of-the-Whole Meeting.

FINANCE COMMITTEE - Mr. Swartz

- Mr. Swartz reviewed the recommendations of Bob Dykes from Triad Research that were presented at a Special Board Meeting on April 17, 2012. Those recommendations included a November levy as opposed to an August levy due to a number of factors that make a November levy passage more probable than an August levy. Mr. Swartz, Dr. Shoaf and Mr. Markus also discussed the delinquent tax collection situation that has provided relief to next fiscal year's projected budget. Mr. Markus explained the collection percentage calculation performed by the County Budget Commission and how this affects revenue estimates and, ultimately, levy planning. Mr. Milano reminded everyone that even with the spike in delinquent tax collections, cuts would still be needed going into next year and certainly years following if a second levy request would fail. Dr. Shoaf spoke about budget tightening that has already been done on account of funding cuts imposed upon the District by the State in the amount equivalent to 1.1 mills of the District's funding. A discussion of the timing of the next five-year forecast update and legislation needed for a November levy request was also had. It was noted that the five-year forecast update should be approved by the Board at the May 17 meeting to meet the State's May 31, 2012 deadline, but that the Board has until August 8 to file the necessary documents with the County Board of Elections to have a levy placed on the November 6, 2012 ballot.
- The next Finance Meeting will be on Thursday, April 26, 2012 at 6:00 p.m.

SCHOOL COMMUNITY COMMITTEE - Ms. Goepfert

- Interviews for the Rocky River Public Library Trustee Vacancy will be held on Monday, April 23, 2012 beginning at 4:30 p.m. The appointment will be on the April or May Board Agenda.
- Recovery Resources/Community Challenge has joined forces with the Westshore Enforcement Bureau & McKeon Education Group to host "Risky Business: What You Don't Know Can Hurt You or Someone You Love." This Town Hall event will be held on Wednesday, April 25, 2012 from 7:00 p.m. – 9:00 p.m. at Rocky River Presbyterian Church. This event is funded by the "Substance Abuse and Mental Health Services Administration."
- Recovery Resources is holding a Coalition Fundraiser at Chick-fil-a on May 2, 2012 from 5:00 - 8:00 p.m. 10% of the sales will be given to the Rocky River Coalition for Youth Asset Development.

- On Monday, April 16th, members of the Rocky River Historical Society donated their time to teach second graders about local history. About a half-dozen historical society members came to Goldwood Primary School to present interactive talks about key elements of Rocky River's past days.
- Ms. Anderson announced that OAT testing would begin the week of May 1st for grades 3-8. Accommodations for students who need it are being made.
- Ms. Anderson discussed with the Board, information she dispersed regarding subject areas that the Ohio Department of Education require each district to offer. Discussion ensued regarding the Fitness Policy that our district could adopt waiving a Fitness credit.

- Ms. Goepfert also announced that Linden Park Soccer Fields are officially renamed "The John Honeyman & Pat Gillespie Soccer Fields". The dedication will be sometime at the end of May.
- At the May Board Meeting, retirees will be honored and the High School students will attend to discuss their efforts for the High School landscaping.
