- Eric Kohls sought clarification of contract . General note PCS and Stantec clarification

- Plaster over wall tile disputed. Credit +\$53,000. PCS Mosser will respond with credit on May 23, 2013. Proposal to retain the second floor hallway that was plastered over the tile. Wall will be painted and remained
- Softball field continues to be an issue. Mosser quoted \$120,000 for softball field dugouts and fencing. Mosser will not be given approval to proceed. Jeff Schultz shared that he walked the field with Chris Panichi and Tom Veider for clarification.
- Kevin Green questioned Stantec's coding for #00292

- Eric Kohls sought clarification on claims with no cost. #00013, 00031, etc.
- Jay Milano landscape credit \$60,000. Did it include retention pond? What is the credit? Mosser bid \$23,860 for seeding and plants. Credit being sought. Mosser offering \$16,000 credit. Question: was \$60,000 in the original budget? PCS will determine credit/original budget.
- Credit for metal tile will be submitted by Mosser on May 23, 2013
- PCS estimated credit for Broadcast Room \$75,000. PCS has not presented this credit estimate to Mosser.
- #00136 still being discussed. Additional items will be added to highlighted area per Eric Kohls
- Spec notification book being reviewed
