#### Science Textbooks Update

Fourteen more SMART Boards have been ordered. This will complete all classrooms at Kensington and Goldwood. It will add an additional six boards at the middle school. Tim Shreve and Brian Salco took SMART Board certification training this spring. We now have three in-district certified SMART trainers.

#### Value Added

With regard to the district report card, we are still waiting on Value Added data. Rocky River met AYP due to a 2% adjustment rule. Kudos to Kensington and the High School on the improvement in their performance indices.

A list of facilities' summer accomplishments was given to board members. Maintenance and custodial workers are working hard to complete work by the beginning of school. Walls are again white in the Wagar gym due to the installation of new light bulbs. Dr. Foley announced a special dedication ceremony on 9/1/09 at 5:45 p.m. in honor of a motorized flag donated by Norm Case in memory of his wife, Sally Case. Dr. Foley discussed the new email system, which is a web-based system. She passed out information to the board regarding access.

#### **Financial Review**

The Finance Committee met at 4:00 p.m. on 8/12/09. It was reported that the district's fiscal year ended on 6/30/09 with a larger unencumbered balance than expected, although the balance of approximately \$330,000 was still small relative to the district's total operating budget. Mr. Swartz, Finance Committee Chair, suggested a change to the committee's standing meeting date and time from 4 p.m. prior to the Committee-of-the-Whole meeting to 6 p.m. before the regular monthly board meetings for at least the remainder of calendar 2009. Mr. Swartz stated that this would give committee members more time to review and study the end-of-the-month reporting package provided by Greg Markus, Treasurer. All Board Members agreed to the change, so Mr. Markus will post the meeting date and time change prior to September's meeting. The District received two of four real property tax advances from the county auditor during July. A third advance is expected on August 14 and a fourth advance is expected sometime in November. Mr. Markus also reported that collections from the new 5.9 mill levy passed in

May 2008 continued to be collected in July, which now will represents a fullyear collection of this new levy for the first time. He also reported that Cuyahoga County has been getting information out sooner to the District's on account of their new property tax collection system and will most likely settle the second half 2008 tax year collection cycle no later than October and possibly in September. They will also be able to update us on delinquencies in a more timely manner. A portion of state guaranteed money received through the foundation formula is now being subsidized by the federal State Fiscal Stabilization Fund through the federal stimulus bill at just under \$40,000 for the current fiscal year. Lastly, Mr. Markus reported that the District just received a check for approximately \$22,000 from the Ohio Schools Council, which is a refund on prepaid electricity billings. The Board also approved the rollover of bus acquisition notes after a portion of the principal was retired.

Mr. Milano arrived at 5:50 p.m.
