- Ms. Anderson reported on the success of the 2014 summer programs offered through RRCSD:
 - $\circ~$ Summer school fitness had the following enrollment: session 1-22 students; session 2-20 students.
 - All students involved in third grade summer reading intervention were successful and will be promoted to fourth grade.
 - $\circ~$ Five students participated in summer OGT intervention and successfully passed the summer administration of the OGT.
- Ms. Anderson shared that several professional development programs have taken place over the last few weeks:
 - 2 days of Foundations training for new K-3 teachers and tutors
 - 1.5 days of PD for 6-8 math teachers
 - Non-violent crisis intervention training programs with twelve (12) district aides. Every RRCSD employee is required to complete non-violent crisis intervention training.
