Superintendent's Report

- The counselors from RRHS presented the new plan for student recognition to the Board that includes improvements in practices for class rank, valedictorian/salutatorian, weighted grades, academic letter, and honor roll
- Ms. Anderson reported that the spring 2014 OGT preliminary scores at RRHS were again strong: writing 98.6%; reading 99%; math 97.6%; social studies 97.1% and science 95.7%.
- Dr. Shoaf advised the Board that the traffic engineer working on the RRPL/RRMS traffic study will present at the Committee-of-the-Whole meeting on June 11th.

Finance Committee

• Mr. Swartz reported that the finance committee met at 4 p.m. prior to the full board meeting to review April financial reports and perform a final review of the proposed five-year forecast update scheduled for approval this evening. Mr. Swartz indicated that the forecast was reviewed by our Citizens Finance Committee and the District is currently in good financial standing. The forecast reflects recently approved personnel contracts as well as what we feel are conservative revenue assumptions, particularly as they relate to property tax revenues. Mr. Swartz further indicated that delinquent property tax balances are down and collections are above estimates, which help with the District managing some increased pressures in various expenditure areas, and therefore projects a positive ending to the current fiscal year.

School-Community Committee

- Ms. Goepfert introduced Jodi Penwell, the newest Rocky River Public Library Trustee to the group and presented her with a Resolution from the Board of Education.
- Ms. Goepfert reported that the Parks and Recreation Commission recently added Pickle-ball to the adult activity programs to be offered through the recreation department.
- Dr. Fancher had several items to report on from the recent Rocky River Education Foundation meeting:
 - o The Foundation awarded over \$40,000 in scholarships this year;
 - o The Foundation elected new Trustees to the their Board;
 - o The Foundation raised \$46,467 in March at their annual fundraiser (over \$11k more than last year), and;
 - o Announced that next year's fundraiser will be held on March 21, 2015
