The following is an overview of the December 16, 2010 Regular Meeting of the Board of Education.

# Action

- ∞ The Board passed a Resolution to Recognize Zachary Paull as an Eagle Scout.
- ∞ The Board passed a Resolution to Establish the 2011 Organizational Meeting.
- ∞ The Board passed a Resolution to Appoint the President Pro-Tem and the Vice President Pro-Tem.
- ∞ The Board passed Resolutions approving the November 2010 Financial Statement and Intrafund Transfers for General Accounting; Resolution to Amend Appropriation; Resolution to Receive Advances on Tax Settlement Amounts from the Cuyahoga County Treasurer for Calendar Year 2011; Resolution to Approve Then and Now Certificate.

#### Finance – Mr. Swartz

- ∞ Delinquent tax advances were received during November, but the District's total delinquent account balance is still tracking higher than the previous year. Once the first half calendar year collections are settled in March/April, Mr. Markus will be able to receive an updated listing of delinquents and assess the impact on the District's budget for the rest of the fiscal year and the subsequent year.
- ∞ Overall expenditures are running below estimates at this point in the year and are running just about even as compared to this point in fiscal 2010.
- ∞ Mr. Markus continues to work with the District's investment advisor to place investments from bond issue proceeds in line with the expected construction spending timeline and will continue to look for opportunities to earn additional yield in the currently depressed investment environment.

## **Rocky River Parks and Recreation**

- ∞ Ms. Goepfert announced that memberships at the Recreation Center are up. "The Silver Sneakers Program" accounts for a lot of the increase in membership.
- $\infty$  New programs for the Recreation are slated to begin in January, 2011.
