The following is an overview of the March 25, 2010 Regular Meeting of the Board of Education.

## Action

- ∞ The Board passed resolutions approving the February 2010 Financial Statement and Intrafund Transfers for General Accounting; Resolution to Amend Appropriation.
- Retirements and Resignations, Supplemental Duty Appointments and Adjustments in Salary and Assignments were approved with one correction of rate of pay for Interscholastic Coaching.
- $\infty$  The Board approved a Resolution to Approve Leave of Absence.
- ∞ The Board approved a Resolution to Approve Rate of Pay for Long Term Substitute Teacher.
- ∞ The Board approved a Resolution to Approve Rate for Summer School Teachers.
- ∞ The Board approved a Resolution to Adopt Guidance Courses of Study.

- Goldwood Primary School presented a "Multimedia Science Presentation". Several Goldwood Students along with Ms. Jennifer Norman, Principal, Mrs. Anne Davis and Mrs. Kristen Hargett presented their science book online along with their experiment of making lemonade. Excellent job!
- Dr. Michael Shoaf welcomed a Boy Scout Troop visiting the board meeting for work on one of their badges. Mr. Swartz spoke to them about how the board and school employees work together and that board meetings are required by law for all school districts.
- Dr. Dianna Foley discussed the House Bill 1 requirement for notifying parents in an emergency. Dr. Foley has been working with AlertNow and is asking for the Boards approval to begin a contract with this company so that we will be in compliance with House Bill 1 for the beginning of the 2010-2011 school year.
- Dr. Shoaf announced that he and Dr. Foley met with Goldwood first grade students and Ms. Norman to discuss Goldwood School.
- Goldwood's kindergarten enrollment at this time is 149 children for the 2010-2011 school year.
