Math Expression received Best in Show on "Organ Donation"; at the 69<sup>th</sup> Model UN Conference the HS students received an Excellent and Honorable Mention and the HS Wind Ensemble received a Superior #1 rating in the OMEA state level competition. Ms. Ann Brokaw, RRHS Science teacher, received the Kim Foglia AP Biology Service Award. The Business Course of Study will be on the June Regular Board Meeting Agenda.
- Dr. Shoaf discussed the 8-step process for cleaning the floors at the high school that Adam Sywanyk has been working on. Dr. Shoaf is very impressed with how nice the floors are looking.

## **Finance Committee**

- Mr. Swartz noted that the property tax settlement was received in April and in total was in excess of estimates by \$66,000. The District also received a scheduled property tax advance earlier this week and it was \$439,000 in total, with \$382,000 credited to the General Fund. This was significantly over the anticipated amount of \$79,000 expected for the General Fund. Mr. Markus will follow up with the County Fiscal Officer to determine if additional delinquent taxes were collected between the settlement date in early April until the advance cutoff date of May 7.
- Mr. Swartz also noted that the finance committee reviewed the five-year forecast update for May 2013 in detail at their meeting earlier this evening and it was on the agenda for approval by the Board.

#### Other

• Mrs. Rounds attended the Young Authors Conference held at the Stocker Arts Center at Lorain County Community College. Mrs. Rounds was excited about meeting Author Tim Green and thrilled with how the conference has grown over the years since she had a hand in starting and organizing this event.
