The following is an overview of the August 19, 2010 Regular Meeting of the Board of Education.

Action

- ∞ Under Policy and Legislation, there was a First Reading of New and Revised Policies.
- The Board approved the schematic design presented on August 11, 2010 by Burt, Hill Architects for Beach School.
- ∞ The Board passed Resolutions approving the July 2010 Financial Statement and Intrafund Transfers for General Accounting; Resolution to Amend Appropriation; Resolution to Designate Public Depositories for Funds; and Resolution to Participate in the Ohio Schools Council Workers' Compensation Group Rating Program.
- Retirements and Resignations, Appointments for Certificated Staff, Supplemental Duty Appointments, Appointments for Support Personnel and Adjustments in Salary and Assignments were approved.
- ∞ The Board approved a Resolution to Approve Rate of Pay for Long Term Substitute Teacher.
- ∞ The Board approved a Resolution for Transportation of Developmentally Disabled Students.

- ∞ The Board approved a Resolution to Discard, Sell and/or Donate Surplus Property.

- ∞ Dr. Foley announced that the 230 leased computers have all been deployed. Newly ordered SmartBoards are in the classrooms.
- ∞ Dr. Foley distributed the RRApps/Student brochure that students will receive. As of August 19, 2010 GoogleApps accounts have been created for students in grades 3-12 and email accounts have been created for students in grades 5-12.
- A GoogleApps Trainer will be holding classes for staff in September and October, Monday and Wednesday each week after school. The classes will be held in the computer lab at the Middle School, 2nd floor.
- ∞ Tech 1 certification classes where held this summer.
- Ms. Anderson announced that four different, district-sponsored professional development classes successfully occurred this August, one of which ran in partnership with St. Christopher School.
- ∞ Mentors have been assigned to new staff.
- ∞ Textbooks have been ordered and will be ready for the beginning of the school year.
