a. Finance - Mr. Manoloff

i. Review of proposed debt refunding - Mike Prcela of Sudsina & Associates

Mr. Manoloff brought forth a follow-up discussion on a possible bond refunding of certain outstanding debt of the District in order to save interest costs for the District taxpayers. He briefly outlined the issue being considered to-date and then asked Mr. Prcela to present his most recent analysis that he had prepared with assistance from Mr. Markus, Treasurer. Based on current valuation of the District's taxable property and discussions with Mr. Markus, he presented a scenario of levying 3.95 mills for debt service for collection years 2018 - 2021, along with a contribution of funds from the District's current bond retirement fund balance that would allow a refunding of approximately \$7.445MM of existing debt for a present value savings in excess of \$600K, which would be over 8% of the debt being refinanced. The minimum benchmark for savings on a debt refunding is 3% as noted by Mr. Manoloff and Mr. Prcela. This millage amount includes the other outstanding bonds of the District as the 1998 Middle School bond issue would be completely retired as of December 1, 2017, and would reflect a 2.53 gross millage "drop-off" to the taxpayers (2.21 mills net of the lost homestead and rollback credit from the state on this millage). This refunding amount would also allow the District to stay within the \$10MM bank qualified debt limited for calendar year 2017 given a lease/purchase borrowing that has occurred already for the Beach preschool renovation project and for a planned lease/purchase financing for technology equipment purchases planned for this fiscal year. Further, Mr. Prcela and Mr. Markus noted that the timing for refunding is very good at this point due to general market and interest rate conditions, but that waiting much longer would add further interest rate risk due to the general outlook of the market based on expected Federal Reserve interest rate increases that are anticipated in calendar year 2017. Mr. Manoloff, Mr. Markus and Mr. Prcela answered various questions from board members and administrators regarding the timing of a possible refunding as well as the effect of the "drop-off" for taxpayers that would ultimately be realized on property tax bills starting in 2018. After further discussion, the consensus was that there should be additional review of the details and effects on property tax millage before considering any resolution to proceed with a refunding. Mr. Markus was asked to schedule a special board meeting to occur the week of February 20 for the Board to discuss this issue further and ultimately consider a resolution to authorize the Treasurer/CFO to proceed with such a refunding. Mr. Prcela was asked to attend the pending special meeting to answer further questions.

A robust discussion was led by Mr. Manoloff regarding the mechanics of the debt refunding based on the last presentation by Mr. Prcela of Sudsina & Associates. Mr. Manoloff drew a chart on the whiteboard to illustrate the millage "drop-off" from the Middle School bonds and how the debt refunding will be structured given the parameter of levying 3.95 mills for debt service starting in 2018. It was confirmed that the savings to the taxpayers would be equal to 2.53 mills based on what would be needed to pay accelerated debt service in calendar years 2017 – 2021. It was also confirmed that the District had the capacity within its bond retirement fund to fund \$500K in order to make this transaction work to the benefit of the taxpayers for a present value savings in excess of \$600K. Mr. Markus indicated that the millage drop-off of 2.53 mills (2.21 net mills after the lost homestead and rollback credit was considered), combined with the May 2017 operating/permanent improvement levy request of 4.9 mills, would net out the additional cost per \$100K of property valuation to a residential taxpayer to approximately \$8 per month. Mr. Prcela concurred that he and Mr. Markus agreed with the analysis and that it would be in the best interest of the District and taxpayers to move forward with the proposed debt refunding at this time.
