The Board of Education of the Rocky River City School District, Cuyahoga County, Ohio, met in a Facilities Committee session on October 29, 2018 at 5:02 p.m. in the Fireside Room at the Board of Education Offices. A digital recording was made of this meeting and is on file in the Office of the Treasurer.

PRESENT AT THIS MEETING: Dr. Fancher, Ms. Leitch

A discussion was held on the following items:

- Dr. Fancher and Ms. Leitch asked Dr. Shoaf to provide his thoughts on the priority of the projects being considered. Dr. Shoaf indicated that he feels all of these projects are worthwhile and that they should all be considered with long-term financing that would fit within permanent improvement fund resources.
- Ms. Leitch and Dr. Fancher asked Mr. Markus about available financing options and if all of the projects could be undertaken. Mr. Markus stated that he believes they can be given an extended financing term of at least 10-12 years and that he is currently working with several banks to come up with possible financing options, including separating equipment purchases into separate, shorter payback schedules as we did for the Preschool project. He will plan to report to the Board at a future finance committee meeting on the realistic financing options and how these projects will fit within projected resources.
- Dr. Shoaf also indicated that other projects such as air conditioning in the High School Wagar lobby/entrance area, Wagar Gym and Goldwood Gym should also be considered with the project currently being discussed to wrap into one financing if possible. Cost estimates for this additional work would need to be obtained from TDA. Ms. Leitch also asked if the refacing of the stadium ticket booths and concession stand were included in working cost estimates, and it was concluded that they were not, so we should consider these costs. Mr. Markus will work with a total estimate of \$1.8MM as of now for planning purposes.
- Mr. Markus, Dr. Shoaf and Mr. Sywanyk also discussed the idea of having TDA perform a
 district-wide facilities assessment. It was agreed by Dr. Fancher and Ms. Leitch that this
 would be worthwhile to pursue, so Dr. Shoaf will reach out to TDA on this issue and obtain a
 quote for such a service.
- Mr. Markus brought up the issue of TDA's expiring contract at the end of December, so he will work with legal counsel to come up with a recommendation to extend or renew the current agreement for multiple years to bring back to the Board for further discussion. Dr. Fancher and Ms. Leitch expressed their agreement with this approach.

• Dr. Fancher also inquired about exterior signage needs at Beach Preschool and the Board of Education Offices. Dr. Shoaf and Mr. Gifford indicated that this issue has been looked at briefly in the past, but they will pick this issue up and come back with some recommendations.
