FINANCE COMMITTEE - Mr. Swartz

Discussion was held on the following items:

The Finance Committee last met on September 17, 2009. Mr. Markus announced that he did receive some feedback on the District's bond rating review from Moody's since that time. Rocky River City Schools has been rated preliminarily as Aa3, which is a slight downgrade from the Aa2 we were rated. Our low fund balance levels as compared to historical averages and peer Districts is what they focused on in their review and subsequent decision to downgrade the rating. Mr. Markus has been in contact with Mr. Manaloff, District bond counsel from Squire, Sanders & Dempsey, as to what this means for us in terms of future debt issuance and other issues going forward, although it is not expected to have a significant impact since we are still rated in the Aa category.

The next Finance Committee meeting will be on Thursday, October 15th at 6:00 p.m. Mr. Markus will review the current draft of the 5-year forecast that will be distributed to the Board by the end of the week.

CURRICULUM COMMITTEE - Mrs. Rounds

Discussion was held on the following items:

CAC Update

The Curriculum Advisory Committee (CAC) met on October 7, 2009 and it was a great success. In order to fulfill the House Bill I request for a Parent/Community Engagement Team, Ms. Anderson will use her CAC Committee, with the addition of Mrs. Barb Reddy, our school nurse, to fulfill that requirement.

PDK Gallup Poll Discussion

Mrs. Rounds discussed the 41st Phi Delta Kappan Gallup Poll rating the schools. Again, lack of funding, discipline and over-crowding were cited as the biggest problems for public schools. Personal qualities in a teacher and their dedication and enthusiasm were written about in this article also. All day kindergarten was endorsed by the participants in the gallop poll from PDK.

High School Course Selection Summary

Ms. Anderson distributed a course catalog survey of twenty-six state high schools. Discussion will follow at a later date.

Title I PLUS Supplemental

Monies earned from selling AP science texts on eBay will be shared between the science and business departments.
