# **Schedules at RRHS**

Rocky River High School operates on a seven (7) period day and school begins at 7:55 a.m. on Monday, Tuesday, Thursday and Friday. Doors open at 7 a.m. for students who arrive early. Any student arriving after 7:55 a.m. must report to the main office.

Each Wednesday, RRHS operates on a 1-hour delayed start schedule, meaning school begins at 8:55 a.m. The reason for this delayed start is to provide collaboration time for staff development. This is known as Professional Learning Communities (PLC). Teachers meet during this hour each week to interpret data, work on curriculum initiatives and to discuss student achievement.

#### What is a Student PLC?

Oftentimes, class meetings are held for students on Wednesday mornings. An example of this would be the 'RRHS PLC for Seniors' on September 1st. This means that all 12th graders need to attend a mandatory meeting in the auditorium beginning at 7:55 a.m. Throughout the course of the year, meetings will be held for different grade levels to cover specific topics. Attendance at student PLC meetings is mandatory unless otherwise stated. Attendance is taken and not showing up to a PLC is treated the same as not showing up for class.

#### What is the Option Program at RRHS?

Junior and senior students are eligible for the privilege of Option. Option means that students who have a 1st or 7th period study hall may start their day late or end their day early. Students are not permitted to have both 1st and 7th period option. Lunch Option allows junior and senior students to leave the school building during their lunch period. Option is only available for junior and senior students who submit all appropriate paperwork and who maintain good attendance, behavior and academic records. # Search for Children With Disabilities Underway

In accordance with the Individuals with Disabilities Education Improvement Act (IDEA) of 2004, The Rocky River City School District is participating in Child Find efforts to locate, evaluate, and identify all children from birth through 21 years of age with disabilities, regardless of their situations, who have significant, individual needs and require intensive interventions through special education and related services.

A disability, in this instance, means such conditions as autism, deaf/blindness, multiple disabilities, deafness/hearing impairment, orthopedic impairment, visual impairment/blindness, specific learning disabilities, preschoolers with a disability, emotional disturbance, cognitive disabilities, speech and language impairments, orthopedic and other health impairments or traumatic brain injury.

Although many school aged disabled children are identified and currently being served by the Rocky River City School District, preschool children ages 3-5 with disabilities may be unidentified because parents may not be aware that programs and services are now available through the public school. Community members can help us with this important effort. If you know of a child in our district with a disability that is not presently attending school or receiving services from another agency, please contact Jennifer Norman, Executive Director of Pupil Services at 440.356.6006.

In addition and in accordance with Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act Amendment of 2008, Rocky River City School District is participating in Child Find efforts to locate, evaluate and identify all children with a disability. In this instance, a student with a disability who has a mental or physical impairment that substantially limits a major life activity because of disability, needs or is believed to need special education, related services or aids or accommodations/modifications. If a parent or guardian suspects that a child may be eligible under this federal definition, please contact Jennifer Norman, District Compliance Officer.

#### **Attendance**

Consistent attendance is essential for academic success and will be a focus at RRHS for the coming school year. With the implementation of House Bill 410, attendance tracking changed from days to hours. Due to this change, RRHS will be tracking period attendance each and every day to ensure we are meeting state guidelines. The focus of HB 410 is to improve students' attendance at schools and to work with families to provide solutions when students are not attending on a regular basis.

#### Arrival/Dismissal

Drop-off and pick-up times can cause congested parking lots. Please be aware that if you pick up your child in the Wagar lot, there is one lane for pick-up and one lane for exiting the premises. Students can also be dropped off and picked up in the Detroit Road parking lot. Utilizing both parking lots helps create a smoother arrival and dismissal process.

#### **Social Media**

Social media can be an excellent tool when utilized correctly. Please keep an eye on your child's social media accounts and continue to have open discussions with them about what they post online. Many colleges and employers look into individual's social media histories prior to admitting or hiring them.

## **August 18-19: In-Person Fee Payments**

School begins promptly at 7:55 a.m. The warning bell rings at 7:45 a.m. Doors open for students at 7:00 a.m.

RRHS picture day is provided by Ripcho Studios. Students will be photographed during their English classes.

#### **September 1: Senior PLC**

All Seniors are required to attend a PLC on Wednesday, September 1st at 7:55 a.m. in the high school auditorium. This PLC will focus on college and career planning.
