This Addendum 1 is issued this 26th day of June, 2014, and it states as follows:

A. The Specifications are hereby amended to include all labor and materials for the following:

1. Add to Work description for "Parking Lot Fence" (see below) - Turn-style repair (replacement of approximately 8 arms).

Please note that the original scope of Work, as stated in the Legal Notice, includes all labor and materials for the following:

1. Track Fence

- a. Install approximately 1400 feet of 4' high chain link fence
- b. Replace wire and rail (1" 8 GA. Mini-Mesh Wire 1 5/8" 40WT Rail)
- c. Replace 8 double gates
- d. Re-grade and pull posts straight
- e. Add all new hardware on fence
- f. Removal of existing chain link fence by Rocky River City Schools' staff
- g. Painting of poles by Rocky River City Schools' staff

2. Parking Lot Fence

- a. Add approximately 250" of 6' high chain link fence
- b. Replace wire and rail (2" 8GA. Vinyl Coated Wire 1 5/8" 40WT Rail)
- c. Replace 2 double gates
- d. Replace 1 walk gate
- e. Re-grade and pull posts straight
- f. Add all new hardware on fence
- g. Removal of chain link fence by Rocky River City Schools' staff
- h. Painting of poles by Rocky River City Schools' staff

3. Grandstands Fence

- a. Add approximately 230' of chain link fence (2" 8GA. Vinyl Coated Wire 1 5/8" 40WT Rail) sides & rear
- b. Add approximately 128' of 42" (Mini-Mesh 1") across front of grandstands
- c. Adjust front railing if possible (Please note that Kee Klamps may be rusted on) or replace
- d. Replace wire and rail
- e. Add mid rail on fence on top of grandstands

- f. Add 2-42" x 5' Ornamental aluminum railings either end of press box
- g. Temporary fence supplied during installation to prevent unauthorized entering of grandstands
- h. Add all new hardware on fence
- i. Removal of chain link fence by Rocky River City Schools' staff
- j. Painting of poles by Rocky River City Schools' staff

Please Note: Add additional \$100-\$250 for fence post replacement.

B. ESTIMATE OF CONSTRUCTION COST

The revised estimated construction cost for the Project is \$50,800. The estimate of construction cost is provided for the bidder's information only and will be used by the Owner as a guide for award of contracts in light of the estimate of construction costs for the Project and related projects.

C. ALTERNATE No. 1

Please bid as Alternate No. 1 the following item of Work (including all labor and materials):

Use 1" 8 GA. Mini-Mesh Wire <u>2"</u> 40WT Rail for "Track Fence" item b. (see above) instead of 1 5/8 40WT Rail for Track Fence item b.
