OTHER BUSINESS

Ms. Olander expressed her concerns about the level of involvement that high school counselors have with testing administration and how this may affect security and the time they have to devote to student needs. Other board members asked for clarification of the testing process and an overview of responsibilities of various employees, including administrators and designated test coordinators. Ms. Norman and Ms. Anderson also responded with clarification of the roles and responsibilities surrounding testing administration and reinforced the philosophy that student needs would always take precedence over administrative tasks. Ms. Goepfert asked Ms. Anderson to include this topic on the next Curriculum Committee meeting agenda.






